### **NAMPA & MERIDIAN IRRIGATION DISTRICT** **SETS ELECTION OF BOARD MEMBERS FOR NOV. 5**

As prescribed by Idaho Law the Nampa & Meridian Irrigation District has set November 5 as the date for an election to pick two members for its Board of Directors, NMID officials have announced.

The District is currently taking candidate nominations until September 26 for a two-year term as Director for Precinct No. 2 to finish the remainder of the term now held by Monte Janicek.

Nominations are also being taken until September 26 for the three-year term as Director for Precinct No. 3 now held by Clinton C. Pline.

NMID Precinct 2, Meridian, is roughly bordered by McMillan Road to the North, McDermott Road to the West, Eagle Road to the East and Hubbard Road to the South. NMID Precinct 3, Nampa, is approximately bordered by McDermott Road to the East, Ustick Road on the North, Bennett Road to the south and Frost Road to the west. A map is available on the District's web site, Election section Notice of Director Election illustrating the precinct boundaries

Individuals who want to stand for election as a Director must live in the Precinct they want to represent plus meet other qualifications set down by law. Individuals interested in running for either Director position can contact the District for more information at 466-7861. Information, including Director Election Petitions is also available on the NMID website at [www.nmid.org](http://www.nmid.org).

Under Idaho law, if the deadline for nominations has passed and only one qualified candidate has been nominated, an election will not be held. Instead, the Board of Directors will declare the candidate as elected.

People who want to vote in the NMID election will be required to sign an elector's oath stating they are a resident of Ada, Boise or Canyon Counties and they own land within the boundaries of the Nampa & Meridian Irrigation District.

The polls will be open on Tuesday, November 5, 2013 from 8:00 a.m. to 8:00 p.m. Eligible voters can cast their ballot at any of the three NMID voting locations. They are:

- *Precinct 1: Horizon Elementary School, 730 N. Mitchel, Boise, ID;*
- *Precinct 2: Meridian Middle School, 1507 W. 8th Street, Meridian, ID; and*
- *Precinct 3: Nampa Civic Center, 311 Third Street South, Nampa, ID*

The Nampa & Meridian Irrigation District is a water storage, conveyance and distribution system founded in 1904. The District supplies irrigation water to some 69,000 acres of farmland, residential and commercial lands including pressurized irrigation for more than 15,000 individual parcels of land in Ada and Canyon counties.
