Early, Absentee Voting Now Open In Nov. 5 Irrigation District Nampa Precinct Director Race

Absentee voting is now open to Nampa & Meridian Irrigation District voters who will decide November 5 who they want to be the Director of the Nampa Precinct 3, officials with the valley's largest irrigation district announced today.

Susan Wonnacott and Clinton C. Pline will vie for the position on the election ballot. Pline is the incumbent while Wonnacott will challenge him for the post. The person receiving the most votes will be declared elected at the canvass of election returns meeting set for later in November, according to Daren Coon, NMID Secretary Treasurer.

“District voters can now request absentee ballots which we will then mail to them. NMID Director elections are very important because the person voters choose will represent the Nampa precinct on the District's three-person Board of Directors. It is the Board members who manage the overall operation of the NMID irrigation water delivery operation,” Coon said.

NMID patrons from all three precincts can vote in the election. Early voting, either by absentee ballot or in person at the NMID office is allowed. NMID voters who want to do so should contact the NMID District office at 208-466-7861 for more information

NMID voters who want to cast their ballot in person on November 5 can do so from 8 am – 8 pm at the following locations:

- Precinct No. 1 – Horizon Elementary School, 730 N. Mitchell Boise, ID 83704
- Precinct No. 2 – Meridian Middle School, 1507 W. 8th St. Meridian, ID 83642
- Precinct No. 3 – Nampa City Hall, 411 3rd St. South Nampa, ID 83651

Idaho law requires that individuals voting in the election complete an oath in which they certify they own land within the boundaries of the Nampa & Meridian Irrigation District; that they are a resident of Ada, Boise, or Canyon County and that they possess all the qualifications required by Idaho's general election laws.

The Nampa & Meridian Irrigation District is a water storage, conveyance and distribution system founded in 1904. The District supplies irrigation water to some 69,000 acres of farmland, residential and commercial lands including pressurized irrigation for more than 17,000 individual parcels of land in Ada and Canyon counties.
